

Gold Star VOA Country Music Fest Ticket Sweepstakes
OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKES. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the VOA Country Music Fest Ticket Sweepstakes (the "Sweepstakes") is open to participants who are: (i) legal residents of the States of Ohio, Indiana, and Kentucky; and (ii) 21 years or older at the time of entry. Employees of Gold Star Chili, Inc. ("Sponsor"), Further Concepts and Investors, LLC, and its affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. The term "family members" includes spouses, parents, grandparents, siblings, children, grandchildren and in-laws, regardless of where they live. Persons belonging to or affiliated with a professional acting, theater, or film-making organization, such as SAG or AFTRA, are not allowed to compete in the Sweepstakes or participate in any entry. Professional actors and filmmakers, whether full-time or part-time, are allowed to compete so long as they do not belong to any professional organizations connected with the entertainment industry that would cause Sponsor to pay the entrant or any other person a fee or any other benefit for taking part in any Sweepstakes event.
3. **How to Enter.** The Sweepstakes will begin at 12:01 a.m. Eastern Standard Time ("EST") on July 14, 2025, and end at 11:59 p.m. EST on July 31, 2025 ("Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

There are two ways to enter the Sweepstakes during the Sweepstakes Period:

- Mobile App

- o Make an eligible transaction of any amount at any participating Gold Star Chili location and scan the Gold Star Mobile App (the "App") to receive one (1) entry. Eligible transactions may be made via the App, in store, or at the drive-thru.
- o To enter via the Mobile App method, you must have an account on the App. If you do not have the App, download the app for free through the Apple iTunes or Google Play stores, and follow the prompts to create an account. **Standard data rates apply.**

or

- On Sponsor's website: visit the Sweepstakes page on Sponsor's website (goldstarchili.com/voacountrymusicfest) and complete the entry form with all required information, including your name, email and phone number.

Entries submitted in compliance with the foregoing and all other terms in these Official Rules are hereafter referred to as "Entries" or, individually, an "Entry."

Limit: One (1) entry per day, regardless of method of entry.

The use of multiple identities and/or accounts is prohibited, and any attempt to obtain more than the stated number of entries will void that participant's entries and may result in participant's disqualification. Incomplete, forged, altered, automated, mechanically reproduced, lost, late, misdirected, garbled, or illegible entries, or entries that do not meet the size or formatting requirements specified above, will be disqualified. Sponsor will not be responsible for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender, Sponsor, or Sponsor's Sweepstakes application service provider. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent, provided that such person satisfies all other Sweepstakes eligibility requirements.

For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the Internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account.

By entering, you hereby grant to Sponsor a perpetual, irrevocable, exclusive, worldwide, royalty-free, sub-licensable, freely assignable license to reproduce your Entry and to otherwise use, exploit, copy, modify, adapt, edit, publish and display the Entry in any form, manner, venue, media or technology now known or later developed for any and all purposes, including, without limitation, for purposes of commercial or trade purposes, advertising, and promotion as Sponsor and its licensees or assignees determine, without further compensation, notification, or permission. Further, by entering, you hereby waive any moral rights you may have in any Entry in favor of the Sponsor. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted or the owner of an ISP account shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons who submit false or misleading entry information or who Sponsor determines to be tampering with or abusing any aspect of the Sweepstakes.

5. **Winner Selection: Odds.** On or about August 1, 2025, Sponsor will conduct ten (10) random drawings and select one (1) potential winner for each drawing from among all eligible Entries received during the Sweepstakes Period. Odds of winning depend on number of eligible Entries received.
6. **Prize Description.** Subject to verification of eligibility and compliance with these Official Rules, the potential winners will receive one of the following prize packages:
 - Two (2) winners will each receive:
 - o Two (2) four-day SUPER VIP passes to attend the Voices of America Country Music Fest in West Chester, OH, August 7–10, 2025
 - Includes food vouchers

 - Two (2) winners will each receive:
 - o Two (2) four-day VIP passes to attend the Voices of America Country Music Fest
 - Includes food vouchers
 - ARV: \$1,200
 - Six (6) winners will each receive:
 - o Two (2) four-day general admission passes to attend the Voices of America Country Music Fest
 - Includes food vouchers
 - ARV: \$700

Please note: all guests of winners of VIP packages must be 21 years of age or older.

Limit: One (1) prize per person and per household.

7. **Winner Notification and Acceptance.** The potential winner will be notified on or about August 1, 2025 after the winners’ selection process via App push notifications, or at the telephone number and/or email provided on the potential winner’s Entry form.

In order to claim a prize, potential winners must respond to Sponsor’s notification within twenty-four (24) hours of notice or attempted notice. Potential winners may be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law), which must be notarized and returned within two (2) business days of notification.

Sponsor’s inability to reach a potential winner after a reasonable (as solely determined by Sponsor) effort has been made, the failure of a winner to timely respond to a prize notification, the

return of any prize notification as undeliverable, and/or a potential winner's failure to comply with any term or condition of these Official Rules may, in Sponsor's sole discretion, result in such potential winner's disqualification and the selection of a substitute winner which will be randomly selected. **If a potential winner cannot attend the prize event, the entire prize is forfeited, and Sponsor will select an alternate winner.**

Prizes and individual components of prize packages are subject to availability. Sponsor reserves the right to substitute prizes or components of prize packages with a prize or component of equal or greater value. Winner is solely responsible for reporting and payment of any taxes on a prize. Winner may be required to provide his/her valid Social Security Number to Sponsor for tax purposes and/or complete an IRS W-9 form in order to claim a prize. Winners are solely responsible for all federal, state and local taxes on prize value and, as applicable, will be issued an IRS Form 1099 based on the prize value determined by Sponsor. Prizes not won and claimed by eligible winners in accordance with these Official Rules will not be awarded and will remain the property of Sponsor.

8. **Participation.** By participating, participants agree to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. In the event the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupt or impair the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date. Proof of sending or submission of an entry will not be deemed proof of receipt by Sponsor.

BY ENTERING, YOU GRANT THE RELEASED PARTIES AN EXCLUSIVE, ROYALTY-FREE AND IRREVOCABLE LICENSE AND RIGHT (BUT NOT THE OBLIGATION) TO TELECAST, BROADCAST, COPY, EDIT, ADAPT, MODIFY, REPRODUCE, PUBLISH, CREATE DERIVATIVE WORKS OF, DISTRIBUTE, USE, OR OTHERWISE PUBLICLY DISPLAY ANY OR ALL OF YOUR ENTRIES, OR ANY PORTION THEREOF, IN ANY MANNER OR MEDIUM THROUGHOUT THE WORLD IN PERPETUITY, FOR COMMERCIAL, PUBLICITY, OR PROMOTIONAL PURPOSES, AND TO LICENSE OTHERS TO DO SO, WITHOUT LIMITATION, REVIEW OR APPROVAL, OR COMPENSATION TO YOU.
11. **Indemnification.** If Sponsor's use of your entry causes Sponsor to be subject to a claim by any third party, you agree to indemnify and hold harmless the Released Parties, and all persons acting by, through, under or in concert with them, against any and all damages, costs, judgments and expenses (including reasonable attorney's fees) which the Released Parties (or any one of them) may incur as a result of the use of your entry.

(BECAUSE SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF CERTAIN IMPLIED WARRANTIES, THE ABOVE LIMITATION MAY NOT APPLY TO YOU. IN SUCH STATES, THE LIABILITY OF THE RELEASED PARTIES IS LIMITED TO THE FULLEST EXTENT PERMITTED BY SUCH STATE LAW.)

THE RELEASED PARTIES, FACEBOOK, INC., TWITTER, INC., AND INSTAGRAM, INC. In the event that any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
