Gold Star VOA Country Music Fest Ticket Sweepstakes OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKES. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

- 2. Eligibility. Subject to the additional restrictions below, the VOA Country Music Fest Ticket Sweepstakes (the "Sweepstakes") is open to participants who are: (i) legal residents of the States of Ohio, Indiana, and Kentucky; and (ii) 21 years or older at the time of entry. Entries submitted in compliance with the foregoing and all other terms in these Official Rules are hereafter referred to as "Entries" or, individually, an "Entry."

Limit: One (1) entry per day, regardless of method of entry.
